Public Service Commission to Hold Public Hearings on Proposed Con Edison Rate Increases

The Village of Scarsdale is notifying residents of a series of upcoming public hearings hosted by the New York State Public Service Commission (PSC) regarding proposed increases to Con Edison's electric and gas delivery rates. If approved, these rate hikes could result in higher utility bills for residential and commercial customers throughout the region.

The Village joined a coalition of over 40 Westchester municipalities earlier this year to formally oppose the proposed increases. The coalition retained legal counsel to represent municipal interests and advocate for greater transparency and fairness in the rate-setting process. As part of these efforts, Mayor Justin Arest submitted a [letter to the PSC](#) in February urging the Commission to reject further hikes and protect residents from unsustainable utility costs.

While the Village and its partners continue to participate in the formal regulatory process, residents are encouraged to be aware of the following public hearings, which offer an opportunity to learn more and provide feedback directly to state regulators.
